Classroom and/or In-Car Driver Education Contract

Your son/daughter _____ has been enrolled in the classroom and/or in-car phase of Driver Education with On The Road Driving School. The state of Virginia requires 36 periods of classroom driver education and 7 lessons of driving and 7 lessons of observation for students 19 years of age and under. (Students 19 years of age and older may hold their learner's permit for 30 days in lieu of completing the driver training course.) All classroom or in-car time missed in the driver education process **must** be completed before any paperwork for licensing is release by On The Road Driving School. (Please fill out page 2)

Instruction is given in a dual-control vehicle which has a brake pedal on the right side for the instructor use and is equipped with restraint systems, extra rear view mirror and a roof to sign. Adequate insurance coverage is carried for the vehicles. The instructors of the program have special preparation for this important work and certified by the State Department of Education.

In the events cancellation of any classroom or in-car sessions, the student will be notified by On The Road Driving School personnel.

Refunds will be given upon request if On the Road Driving School is not capable to begin instruction within 30 days from the date agreed to in the contract. Classroom refunds will be given until a class session begins: however, a 20% administrative charge will be deducted. No refunds will be approved after the start of a class unless special circumstances warrnat.

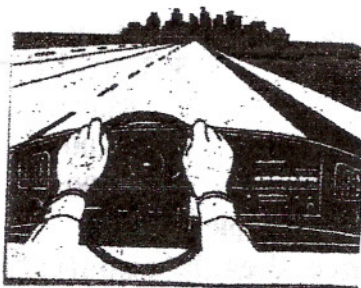
